1. MINUTES OF THE PREVIOUS MEETING

The minutes of the meeting held on 8 Aug '94 at Bothenhampton having been circulated, were accepted as a true record of that meeting and duly signed.

3. RIGHTS OF WAY SURVEY

a. Mrs Bramah gave details of the recent survey carried out by the Ramblers Association of the footpaths in the parish area. It was explained that there is cash available from a number of sources to improve the present state of the footpaths. In general the rights of way in the parish are variable in useage, type and condition, and most need some kind of attention if full advantage is to be made of these most valuable assests.

Miss Fleming gave details of the financial and other help available from County Council rescources, to include assistance with the cost of projects adopted by the parish council for notice boards, village trails, walks etc.

The Council agreed that all members should be provided with a full copy of the report of the Ramblers Association when a decision would be made as to future action to be taken.

4. MATTERS ARISING

Account from MAC Carpenters. It was resolved that in view of the delay in the payment of this account, any concern over its cost should now be disregarded and the account be paid, in full immediately.

Bridleway, Old Church Road. The Clerk reported that investigations with the Land Registry had failed to confirm the owner of this strip of land. The matter had been referred back to the West Dorset District Council and at the time of the meeting a reply had not been received.

Inspections of playground equipment. Clr Blythe reported that the NPFA had not yet inspected the equipment. The slide had now been repaired and was in good working order. The account for RHM Wheeler for £188.70 was approved for payment.

Collections of household waste Uplnads, Waldtich. The Clerk gave details of the reply received from West Dorset District Council.

Dog Bye-law. The Clerk reported that these have now been approved by the Secretary of State and will become law on 1 October 1994. It will be necessary for a suitable copy to be displayed at the entrance of the John Holt Play Area.

Bothenhampton Landfill/CA Site. Mr J Cardwell, Director of Drinkwater Sabey and Dorset Waste Management Ltd gave details of the company's proposals for the future of the landfill site. It is the company's intention to close the Bothenhampton site as early as possible, the stumbling block at present is finding a suitable alternative site in the Bridport area. As soon as a site can be found the Bothenhampton site will be closed within a few months. When the site is closed will be necessary to cap it off. At present the company has specialists investigating the safest and best method of completing this operation. The first steps are to drill bore holes to asceratin the quantity of landfill gases and water in the ground, and this operation is due to start shortly.

The Company's contract contains a restriction of 90 trade vehicles per week to enter the site. It will be necessary to have a certain quantity of 'trade waste' at the site in order to effectively cap it off. Although the company cannot have more than 90 vehicles per week there are occassions when a fewer number will bring the contracted waste in, and when this occurs the company would wish to make up the shortfall with vehicles bringing in trade waste. In the past the Dorset County Council had not made a charge for any trade waste but it was the company's policy from now on to make a charge.

A firm assurance was given that all the time the site was 'active' there would never be more that the contracted number of vehicles of 90 per week coming to the site.

It will be necessary to greately increase the number of heavy lorries coming through the village when the capping operation commences because of the sheer volume of capping material required. It was very much regretted that there was no other access to the site other than through the village, and the company very much regretted the inconvenience that will be experienced by the residents. Every effort will be made to keep the inconvenience to the absolute minimum, and for the capping to be carried out in the shortest time possible.
