a. Footpaths and Roads. Clr Botham drew the meetings attention to the detail of speed control in villages as outlined in DAPTC Newsletter 58/94. After some discussion it was resolved to take no further action at present, but to monitor the situation as it applies to Walditch and report back at a later meeting.

- b. Street lighting. It was agreed to obtain an estimate for a light to be put on the pole adjacent to Spring Hayes bungalow in Old Church Road.
- c. John Holt Play Area.
 - [1] The Clerk drew atteion to the need for the new byelaws to be clearly displayed at the entrace to the play area. The initial estimate is £360. The Council were also informed that Drinkwater Sabey had been approach with a view to their sponsorship of this notice board. It was agreed to await their decision. If this was not successful then consideration would be given to the purchase of the necessary board in accordance with the estimate received.
 - [2] The inspection of play equipment has not yet taken place. All the bark safety surfacing has now been completed. It was resolved to include a sum in the next budget for the replacement and upgrading of the play equipment.

- e. Conservation & Open spaces. The chairman gave details of the recent meeting of the magagement committee and its proposals for the coming year.
