[a] Applications received from West Dorset District Council; Application No 1/W/1998/0258 Full Delegated, 20 Uplands, Walditch, Bothenhampton, construct pitched roof and fit 2 No rooflights to west elevation and 3 No rooflights to east elevation.

[b] Decisions by West Dorset District Council; Application No 1/W/1998/0072 Land Adj. 1 Hyde Cottages, Walditch, Bothenhampton, erect house with garage, construct new vehiclar access. Approved. Application 1/W/1998/0098, Land adj. Hillside Crock Lane, Bothenhampton, develop land by the erection of 3No bungalows and construct new vehicular and pedestrian accesses. Outline permission approved. [c] The Clerk confirmed that WDDC Planning committee would be meeting on the 14 May 1998 at Mountfields at 2.15pm at which we would be given the opportunity to speck of the proposed development at Wychside, Burton Road, Bothenhampton. It was agreed that Mrs.England should represent the Parish Council.

[d] The Clerk read out a letter received from DCC concerning the proposed new sewage treatment works at Wych Farm concerning the landscaping, the contents of which were noted.

## 11. REPORTS FROM;

- [a] Footpaths and Roads; WDDC will be carrying out improvements near the John Holt play area and will keep Mr. Yates informed. Mr. Hulbert reported that he had been informed the surface water drain half way down Walditch Lane will be blocked off and water will be allowed to run down side of lane.
- [b] Street Lighting; Crook Lane and No 9 Main Street.
- [c] Neighbourhood Watch; Lower Walditch NTR, Bothenhampton the network is working.

- [e] John Holt Play Area; See item "a" above work could also take place in the play area.
- [f] Walditch Pay Area; Mr.Batten gave an up date on progress. He had seen the solicitors on the 7 May 1998 and there could be a possible problem over the ownership of the access to the play area. But it is hoped that this matter can be sorted out in the very near future. The question of fees was raised and it was confirmed that these should be in the region of £1,000 £!,200 and had already been agreed.
