The Secretary of the Village Hall Committee presented an estimate from a local contractor for work on the exterior wall, the estimated cost being £4,200 + vat. Work has not yet started and there is uncertainty about start and finish dates.

	 Grant to Churchyards In light of the abolition of the parish council and uncertainty regarding future grants to both Bothenhampton Old Church and Walditch churchyards, The Finance and Funding sub-committee recommends that the Parish Council makes a grant to each of the churchyards to the same value as previous years. The Clerk confirmed that this was £750. Clerk to place on Main Committee Agenda – 4th March 2024. 	
	DIGS Information Panel at Bothenhampton Nature Reserve With regards the information panel for the nature reserve, in the absence of a quotation or any information as to what is required it is difficult for the Finance and Funding sub-committee to make a recommendation. It is suggested that the Parish Council discusses this at the Main Committee meeting of 4 th March, and either drop the matter, or agree an amount they are prepared to offer as a grant - subject to there being an official association or committee with a recognized treasurer and bank account.
