## 1. MINUTES OF THE PREVIOUS MEETING

The minutes of the meeting held on 14 Feb '94 having been circulated, were accepted as a true record of that meeting with the following alterations:

- a. Para 5. add: The Clerk was requested to obtain an up to date analysis of the leachate removed from the site  $\frac{1}{2}$
- b. Para 8. amend to read: Bridport Town Council be asked if they would consider making the necessary arrangements with the appropriate authority to have this section of path made up to an acceptable standard.

#### 3. MATTERS ARISING

- a. Hollow Way and Quarry Lane. The Clerk gave details of the reply received from the County Surveyor.
- b. Bothenhampton Landfill Site. The Clerk gave details of the reply received from the County Waste Disposal Officer. Clr Blythe drew the meetings attention to the very poor state of road surface in Hollow Way resulting from the excessive use of this road by the tankers over a prolonged period. The Clerk was instructed to ascertain when it would be likely that repairs would be carried out.
- c. Footpath to Safeways Store, Sea Road, South. The Clerk gave details of the reply received from Bridport Town Council. The Council expressed their extreme displeasure at the remarks contained in the final paragraph of Bridport Town Council's letter and the Clerk was instructed to reply to Bridport Town Council accordingly.
- d. Dog Bye-laws Childrens' play area. The Clerk gave details of the reply received from the Dept of the Environment. The Clerk was instructed to proceed with the completion of the proforma and prepare a draft bye-law. The resolution to obtain the bye-law to be advertised on all parish council notice boards as soon as possible.

e. Britt Valley Project. The additional names from the Residents Association are Mr H Lee and Mr J Shires. It was agreed that the contact person be changed to Mr G Matthews. The Clerk was instructed to advise Mr Carman, West Dorset District Council, accordingly.

#### 4. REPORTS

- a. Rear Admiral G Pritchard wished to emphasise that it was still only in the planning stages that the landfill site would be closed off in 1999 and warned against taking it as a certainty that the tip would close.
- b. Clr Cracknell reported that the previous unaminity with the Dorset County Council over the local government re-organisation had now fallen through and the sides were now some way apart. Both sides have been at length to explain why their particular proposals are the best way forward.

After some discussion on this point the Chairman drew the meetings attention to the special meeting arranged for 28 Mar '94 to discuss this councils response and invited both Clr Pritchard and Clr Cracknell to attend.

### 5. DEMOCRATIC HALF HOUR

- a. Lower Walditch Lane and Lings Field. The attention of the Council was drawn to the disgusting state of the area of Lings Field. The Clerk was instructed to advise the Environment Control Officer WDCC accordingly.
- b. Manor Fields. The attention of the council, was drawn to the broken street lights in Manor Field. The Clerk explained the difficulty of ascertaining who was responsible for individual lights and agreed to take the matter up with the Lighting Authority County Council.
- c. Lower Walditch Lane road side pavement. The attention of the council was drawn to the generally poor state of the pavement leading into the A35. The Clerk was instructed to take the matter up with the highway authority.
- d. Bowhayes. It was reported that the Road sign has been vandalised and there is a lack of adequate street lighting in this area. The Council agreed to look into the question of obtaining additional lighting in due course.

## FOOTPATHS/ROAD/STREET LIGHTING

- a. Footpath Mountjoy/Coopers Drive. This footpath, although well used does not seem to appear on the definitive map. The Clerk was instructed to find out if this is correct and if so what steps may be taken to have this path classified as a footpath
- b. Footpath Green Lane/Crock Lane. The steps which lead from Green Lane to Crock Lane have for a number of years been maintained on a voluntary basis by a local resident. This has now ceased and it is discussion whether this council should take on this responsibility. The Clerk was instructed to ascertain the ownership of the land which leads down from Green Lane into Crock Lane, when the subject of maintenance of the steps can be fully debated.
