1. MINUTES OF THE PREVIOUS MEETING

3. MATTERS ARISING

- a. Parking problems Bowhayes/Crock Lane. The Clerk read a letter from Dorset County Council regarding the proposed removal of the bank in front of numbers 90 to 104 Crock Lane. and the reply to this council's concern re the "Keep Clear" markings recently laid down by the DCC.
- b. TPO Walditch Road/The Hyde. The Clerk explained that as this is a conservation area no TPO is necessary as any tree felling within a conservation area is subject to a planning application. The Clerk was instructed to write to WDDC requsting that they remind the owners of The Hyde of these conditions regarding the trees.
- c. New Health Authoritiy Boundaries. Clr England was not present and no report was given.
- d. Rented Homes for Rural Areas. Clr Ball gave a report on the Policy Statement of the National Federation of Housing Associations.

4. REPORT FROM CTY & DIST COUNCILLOR

a. Bulky Household Waste. The life of the site has been extended until 31 May 1996. It will be necessary to continue extensions for one year at a time until a new site is found. It was pointed out that the contract conditions require that a new transfer station be found by the contractor within the next two years. It is extremely unlikely that should this condition not be complied with the contract be terminated, but such action would attract a severe financial penalty.

- c. John Holt Play Area. The repairs to the goal post will be put in hand this week. Cost in the region of £40. The chain link fencing is in need of repair. Mr J Bright to be asked to carry out the necessary work. The new play equipment is now installed and is much appreciated by the younger children of the village. Weed killer has been put down around this play area and the bark safety surfacing needs topping up. It was agreed that Mr B Smith be approached to supply what is needed.
- d. Neighbourhood Watch. Clr Hulbert reported that one minor incident had taken place in Manor Fields which had been dealt with promtly by the police.
- e. Conservation and Open Spaces. The main path through the nature reserve area has now been completed. The steps had been taken out but will be replaced shortly. A workshop to make bat and bird boxes is to be held in the Bothenhampton Church Hall on Sunday 22 October '95. It was agreed that close observation should be kept on the progress, or otherwise, of the construction of the open space in Lowr Walditch Lane. Clr Hulberet produced a leaflet that he had received from the Woodlands Trust, the Clerk was instructed to obtain more details of their Millennium Challenge.
